- Artist must be 16 years or older to enter.
- Artist may enter up to two (2) artworks.
- All media is accepted.
- Media must relate to nature/outdoors/natural happenings.
- 2D and 3D artworks can be entered.
- All artworks must be 60"x60" or under.
- Attach ID tags to lower right-hand corner of artwork(s)
- All artwork must have wire on the back for hanging
- Artworks are juried for awards.
