- Artist must be 16 years or older to enter.
- Artist may enter up to two (2) artworks.
- All media is eligible for entry.
- Media must be a black & white composition with the incorporation of only one other color.
- 2D and 3D artworks can be entered.
- All artworks must be 60"x60" or under.
- Attach ID tags to lower right-hand corner of artwork(s)
- All artwork must have wire on the back.

Austin Casebolt (b. 1994) is a contemporary American artist. Casebolt is an award-winning painter, teacher, and artist in residence at the Western Kentucky Botanical Garden. Casebolt is a first-generation college graduate, fast-tracking his career as a professional artist. His work challenges reality and fantasy in layered environments to express a hyperreality inhabited by abstraction and representation. His attention is on presence, in time and space, juxtaposed to the unreliable absence of the past and future with attention on marginalized and vulnerable people. His work can be found in both private and public collections. Additionally, his work from his residency at the Western Kentucky Botanical Garden is on display in the upstairs of the

Miller House - an upscale restaurant and bourbon bar located in the downtown historic district of Owensboro, Kentucky.
